

Privacy Policy

GENERAL

Thank you for visiting www.rlcmultitrade.in or the Personal Website of your authorized RMG Future Independent Distributor whose name appears on the site (our “site”). www.rlcmultitrade.in ("Website") is an Internet based portal owned and operated by RLC Multitrade Private Limited (herein after referred as “RMG FUTURE”), a company incorporated under the laws of India, with its registered office at Delhi, India. As used herein the Privacy Policy “our”, “we”, and “us” refer to both RMG FUTURE and Customer/Independent Distributor (here in after referred as “ID”) unless the context clearly provides otherwise.

This Privacy Policy explains how RMG FUTURE collects, uses, discloses and protects your Personal Information, obtained explicitly through www.rlcmultitrade.in website ("Site"), as well as other information collected automatically without direct submission by you. 'Personal Information' is information that enables anyone to contact you. Your full name, address, IP address, e-mail address are other examples of Personal Information.

You may need to provide RMG FUTURE your Personal Information during the course of using some services of the RMG FUTURE; for instance, while registering on the website and while making an online purchase.

RMG FUTURE recognizes the importance of protecting the privacy of information we may collect from you. To this end, we are committed to using our best efforts to respect your privacy.  - Providing references;
 - Complying with laws and regulatory requirements and assisting with any governmental or police investigation;
 - To send you the latest information about our company, events and promotional emails about new products, or other information which we think you may find interesting using the email address which you have provided;
 - From time to time, we may also use your information to contact you for market research purposes and which will improve our Products and Services. We may contact you by email, phone, fax or mail. We may use the information to customize the website according to your interests; and
 - Other purposes directly or indirectly relating to any of the above.

SECURITY

LICENSE AND SITE ACCESS
